## Report of Implementation of the RCRA Contingency Plan at the Waste Isolation Pilot Plant Facility (EPA I.D. Number NM4890139088) on November 27, 2017

The purpose of this report is to satisfy the requirement in the Waste Isolation Pilot Plant (WIPP) Hazardous Waste Facility Permit (Permit) Attachment D, *RCRA Contingency Plan*, Section D-5, *Required Reporting*, to submit a written report of the incident to the Secretary of the New Mexico Environment Department and to the U.S. Environmental Protection Agency Region VI Administrator within 15 days of implementing the *RCRA Contingency Plan*. The information required to be included in the report is provided below.

- The name, address, and telephone number of the Owner/Operator
  - United States Department of Energy, the owner and operator of the WIPP facility, and Nuclear Waste Partnership LLC, co-operator of the WIPP facility

- The date, time, and type of incident (spill, release, fire, explosion, radiological, etc.)
  - On November 27, 2017, at approximately 11:15 a.m., personnel evacuated the WIPP underground after workers reported a burning smell coming from an electric cart located at S-2520/E-140. An electrician examined the cart and observed a light smoke coming from the motor of the cart (no flames). He disconnected the battery, and the smoke appeared stopped. The RCRA Contingency Plan was implemented on November 27, 2017, pursuant to the criteria in the Permit, Attachment D, Section D-3, *Criteria for Implementation of the RCRA Contingency Plan*:
    - *If a fire occurs in underground that results in immediate personnel evacuation or prevents normal personnel access to the underground*

Although no flame was observed, the incident was addressed as a potential fire.
- The name and quantity of material(s) involved
  - The electric cart was the only item involved in the incident. There was no hazardous waste or TRU-mixed waste involved in the incident.
- The extent of injuries, if any
  - No injuries resulted from this incident.

- An assessment of actual or potential hazards to human health or the environment, where this is applicable
  - There were no actual or potential hazards to human health or the environment. As a precautionary measure, personnel were evacuated from the WIPP underground and personnel access to the underground was restricted until cleared by emergency management personnel and until WIPP facility senior management authorized re-entry into the WIPP underground.
- The estimated quantity and disposition of recovered material that resulted from the incident
  - No materials required recovery or disposition.
- Any additional information/comments
  - Underground access restrictions were subsequently lifted and implementation of the RCRA Contingency Plan was terminated at approximately 11:00 a.m. on November 29, 2017.
