14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.) The purpose of this modification are to update Section J, Attachment A, Government Furnished Property (GFP) List, to include all of the government furnished trailers that are being added or removed from the contract. The revised property listing subtracts trailer number 323 and 324, and adds trailer numbers RH-008 and RH-009. Since under the contract CAST is responsible for maintaining all trailers assigned to it under the contract, CAST should conduct a CVSA level VI inspection on trailer numbers 323 and 324, needed maintenance shall be performed, and the trailers shall be dropped off at the WIPP site trailer parking area.
