Overview of the Permit Modification Notification

This document contains a Class 1 Permit Modification Notification (**PMN**) for the Waste Isolation Pilot Plant (**WIPP**) Hazardous Waste Facility Permit (**Permit**) Number NM4890139088-TSDF.

This PMN is being submitted by the U.S. Department of Energy (**DOE**) and Salado Isolation Mining Contractors LLC, collectively referred to as the Permittees, in accordance with Permit Part 1, Section 1.3.1, (20.4.1.900 New Mexico Administrative Code (**NMAC**) incorporating Title 40 Code of Federal Regulations (**CFR**) §270.42(a)). The PMN in this document is necessary to notify the New Mexico Environment Department (**NMED**) of a change which impacts the Permit. This change does not reduce the ability of the Permittees to provide continued protection to human health and the environment.

The requested modification to the Permit and any related supporting documents are provided in this PMN. The proposed modification to the text of the Permit has been identified using red text and <u>double underline</u> and a strikeout font for deleted information.

Item 1

Description

This modification revises Permit Attachment D, Figure D-1, *WIPP Surface Structures*; Permit Attachment D, Figure D-2, *Spatial View of the WIPP Facility*; and Permit Attachment M, Figure M-58, *WIPP Traffic Flow Diagram*, with the changes described below. These figure changes depict that the area encompassing the New Filter Building (Building 416) is no longer under construction, inclusion of this area into the Property Protection Area (**PPA**) and includes updated information.

- Removed "Under Construction" label and respective cross hatching in the New Filter Building (**NFB**) area from the following Permit figures:
 - Permit Attachment D, Figure D-1, *WIPP Surface Structures*
 - Permit Attachment D, Figure D-2, Spatial View of the WIPP Facility
 - Permit Attachment M, Figure M-58, WIPP Traffic Flow Diagram
- Permit Attachment D, Figure D-1, *WIPP Surface Structures* and Permit Attachment M, Figure M-58, *WIPP Traffic Flow Diagram* is updated with the following changes:
 - Added a marker on the PPA fence line for a new turnstile gate
 - Removed PPA fence separating the NFB area from the previous PPA
 - Added the two plant roads around the NFB area
 - Added the new ventilation system ductwork
 - Added substation next to Pumphouse 490 and in the NFB area
 - Added "FAB" Building (building 418) in the NFB area
 - Changed bldg. 242 to 244 and bldg. 270 to 260 in the legend
 - Added the following building number labels to the figure; 254.2, 254.7, 254.9, 255.1, 255.2 and 351
- Permit Attachment D, Figure D-1, *WIPP Surface Structures,* is updated with the following changes
 - Updated locations for emergency assembly and staging areas
 - Updated legend to reflect assembly and staging area markers

Basis

This change is classified as an "Administrative and informational change" and is, therefore, a Class 1 Permit modification pursuant to 20.4.1.900 NMAC (incorporating 40 CFR §270.42, Appendix I, A.1).

Discussion

This modification is needed to update the above-listed Permit figures to remove the "Under Construction" status from the NFB area, to update the PPA fence line, to add a new turnstile gate to the PPA fence line south of the NFB, and to provide minor updates (described above) to depict the current facility.

The NFB construction is complete and is now operational. Applicable inspections of emergency equipment maintained in the NFB listed in Permit Attachment D, Table D-2 have been initiated.

The respective figures were updated to remove the fence line separating the NFB from the previous PPA to incorporate the NFB into the PPA pursuant to the Class 1 PMN submitted to the NMED on April 3, 2025.

A turnstile gate has been installed in the fence line of the PPA to allow limited entry of personnel working in the New Filter Building area. Entry to the facility will be controlled pursuant to Permit Part 2, Section 2.6.3.

Red boxes are provided on the versions of the figures being replaced to depict the exact areas where changes are being made.




Figure D-1 WIPP Surface Structures





Figure D-1 WIPP Surface Structures

Figure D-2 Spatial View of the WIPP Facility







Figure D-2 Spatial View of the WIPP Facility
