Dear Mr. Kieling:

The purpose of this letter is to request an extension of time for implementation of the referenced 2-item Class 2 Permit Modification Request (PMR), *Training Program Revision* and *Changes Due to Construction and Operation of a New Filter Building*. The New Mexico Environment Department (NMED) made a final determination regarding this PMR on March 23, 2018. The effective date for this permit modification is April 23, 2018. The complete searchable copy of the permit, as modified, will be posted onto the Information Repository on April 23, 2018 pursuant to Permit Part 1, Section 1.14.

Due to the extensive nature of the changes to the Facility Personnel Permit Training Program, the effort required to transfer detailed information from the Permit to the WIPP facility files, procedure changes needed to implement revised Permit Attachment O, and the fact that the requirements in the previous version of the Permit were generally more stringent than the approved revised permit, the Permittees are requesting that the NMED allow for a period of 90 days beyond the effective date of the revised permit for implementation of the approved changes. During this 90-day period, the Permittees will undertake efforts to establish the required WIPP facility files, make necessary procedural changes, and administer the new training courses that are outlined in the revised permit. These efforts will be completed no later than July 22, 2018 (i.e., within 90 days of the effective date of the approved Class 2 PMR). This request is being made per the requirements of Permit Part 1, Section 1.10.3., Extension of Time. Your timely response to this letter is appreciated.
