Subject: Transmittal of the Final Audit Report for CBFO Recertification Audit QAD-A-25-04 of the ORNL/CCP

Dear Mr. Nance:

This letter transmits the Final Audit Report for the Carlsbad Field Office (CBFO) Recertification Audit QAD-A-25-04, of the Oak Ridge National Laboratory/Central Characterization Program (ORNL/CCP), for processes performed to characterize and certify waste in accordance with the Waste Isolation Pilot Plant Hazardous Waste Facility Permit. The audit was conducted April 15 – 17, 2025.

The audit team concluded that, overall, the ORNL/CCP contact-handled and remote-handled transuranic waste characterization programs evaluated are adequate relative to the flow down of requirements, and the technical activities evaluated are satisfactorily implemented and effective, with the exception of Dose-to-Curie which was deemed indeterminate. The Dose-to-Curie was not available for verification and could not be performed during the audit.

The audit team identified five (5) total concerns during the audit. The five (5) concerns were classified as: one (1) Corrected During the Audit; two (2) Observations; and two (2) concerns were offered to management for consideration as Recommendations.
