In accordance with Contract Section B.4, Clause DOE-B-7002, DEAR 970.5232-4 – Obligation of Funds, and Mutual Agreement of the Parties, the purpose of this modification is to obligate incremental funding in the amount of \$8,904,342.32. In addition, work for others (WFO) funding was not included in the funding guidance provided to the contractor. As such, those amounts are reflected in the contract ceiling. This results in a total contract value increase of \$8,735,678.42.
