In accordance with Contract Section B.4, Clause DOE-B-7002, DEAR 970.5232-4 – Obligation of Funds, the purpose of this modification is to provide incremental funding to the contract in the amount of \$42,329,020.45. In addition, work for others (WFO) funding was not included in the funding guidance provided to the contractor. As such, those amounts are reflected in the contract ceiling in the amount of \$5,084,517.81. Further, in accordance with Contract Section B.3 Transition Cost, Anticipated Funding, and Total Available Performance Fee, the total estimated cost of Capital Asset Project CLIN 00009 is hereby increased by \$16,911,768.73 and CLIN 00010 is hereby increased by \$1,136,333.68 to incorporate current funding profile projections. The result of all the actions detailed above is an overall increase to the total contract value by \$23,132,620.22. The contract is modified as follows:

c) The total contract estimated cost is increased by \$23,132,620.22; from \$1,575,286,730.69 to \$1,598,419,350.91.

d) CLIN Obligations are revised as follows:

CLIN 00002 is increased by \$24,280,918.04; From \$599,375,841.86 To \$623,656,759.90;
CLIN 00009 is increased by \$16,911,768.73; From \$152,978,498.62 To \$169,890,267.35;
CLIN 00010 is increased by \$1,136,333.68; From \$119,886,041.58 To \$121,022,375.26.
