H.80 WORK PERFORMED UNDER SECTION C, PERFORMANCE WORK STATEMENT, NOT FUNDED BY THE CARLSBAD FIELD OFFICE

The Contractor is authorized to earn 3% fixed fee directly from the requesting entity on work performed by the Contractor that is funded by non-Carlsbad Field Office (CBFO). Such work will be in furtherance of the Performance Work Statement provided in Section C of this contract.

Funding by non-CBFO will be provided via either the Inter-Entity Work Order (IEWO) or the Work Authorization (WA) in accordance with DOE Financial Management Handbook, Chapter 12 Inter-Entity Work Between DOE Organizations. The Contractor shall keep a detailed documentation of the fund expenditure (DEAR 970.5232-4 Obligation of Funds) for the funding by others. All work performed will be on a full-cost recovery basis and reporting of work will be provided to CBFO on a monthly basis.

This clause is effective for the period February 4, 2023 through November 7, 2032, and will be reviewed at the end of the performance period to determine whether there is a requirement to extend the clause.
