## **Overview of the Permit Modification Notifications**

This document contains two Class 1 Permit Modification Notifications (**PMNs**) to modify the Hazardous Waste Facility Permit (**Permit**) at the Waste Isolation Pilot Plant (**WIPP**), Permit Number NM4890139088-TSDF hereinafter referred to as the Permit.

These PMNs are being submitted by the U.S. Department of Energy (**DOE**) and Washington TRU Solutions LLC (**WTS**), collectively referred to as the Permittees, in accordance with Permit Part 1.3.1 (20.4.1.900 New Mexico Administrative Code (**NMAC**) incorporating Title 40 of the Code of Federal Regulations ((40 **CFR**) 270.42(a)). The PMNs in this document are necessary to notify the New Mexico Environment Department (**NMED**) of a change that impacts the WIPP facility. These changes do not reduce the ability of the Permittees to provide continued protection to human health and the environment.

The requested modifications to the Permit and any related supporting documents are provided in the PMNs. The proposed modifications to the text of the Permit have been identified using red text and <u>double underline</u> and a <u>strikeout</u> font for deleted information. All direct quotations are indicated by italicized text.

### Item 1

## **Description:**

Revise the language in Attachment A1, "Container Storage," Section A1-1c(1) "TRUPACT-III Management" to address manual bolt removal from the TRUPACT-III overpack cover and closure lid.

#### Basis:

The change is classified as "Administrative and informational change" and is therefore a Class 1 notification pursuant to 20.4.1.900 NMAC (incorporating 40 CFR 270.42, Appendix I, A.1).

### Discussion:

In order to address the manual removal of bolts from the TRUPACT-III overpack cover and closure lid, the Permittees are adding the following language to Attachment A1, Section A1-1c(1), TRUPACT-III Management "or manually as required." This change provides the flexibility to remove bolts from the TRUPACT-III overpack cover and closure lid manually when the bolting robot is not operational.

### **Revised Permit Text:**

## • TRUPACT-III Management

The TRUPACT-III containing one SLB2 will be transferred to a Yard Transfer Vehicle in the Parking Area Unit using a forklift. The Yard Transfer Vehicle then transports the TRUPACT-III into the CH Bay through one of the airlocks and into Room 108 for unloading (Figure A1-1b). The TRUPACT-III is first transported to the bolting station where the overpack cover and closure lid are removed using a bolting robot, or manually as required, and a monorail hoist. The TRUPACT-III is then moved to the payload transfer station where the SLB2 is removed from the TRUPACT-III.

## Item 2

## **Description:**

Change the procedure number for the bolting station inspection in Permit Attachment E, Table E-1 from WP 05-WH1209 to WP 05-WH1203.

### Basis:

The change is classified as "Administrative and informational change" and is therefore a Class 1 notification pursuant to 20.4.1.900 NMAC (incorporating 40 CFR §270.42, Appendix I, A.1).

### Discussion:

This change is necessary because the inspections for the Bolting Station and Bolting Robot will be conducted using the same procedure, WP 05-WH1203. There is no change in the frequency or content of the inspection for either piece of equipment.
