14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The purposes of this modification are to:

(1) Obligate funds of \$2,500 for RAP in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. Total contract funding is increased from \$244,492,373.35, by \$2,500, to \$244,494,873.35.

(2) Increase the FY14 anticipated funding shown in Section B.2.2.(b) of the contract in accordance with Special Contract Clause H.55 – Work performed for other DOE entities. The line showing FY14 funding from other DOE entities is increased from \$647,184.82 (in Modification 55), by \$2,500, to \$649,684.82 in Modification 61 for RAP funding provided by DOE-HQ.

(3) Increase contract value from \$1,387,179,119.56, by \$2,500, to \$1,387,181,619.56.
