NWP intends to release a Request for Proposal (RFP), release date pending, whereby the proposed award (an anticipated Firm-Fixed-Price subcontract) will be made to the lowest priced technically acceptable and responsible Offeror that complies with all the technical requirements, delivery date(s), and the general terms and conditions of the RFP, providing the proposal is reasonable and in the opinion of NWP, is in the best interest of NWP and the Government.

Synopsis of the work to be performed is as follows:

- Construct a cast-in-place reinforced concrete pad.
- Supply and install three (3) diesel and one (1) gasoline aboveground 1,000 gallon fuel storage tanks, fuel dispensing systems, and all associated appurtenances.
- Install electrical distribution panel, emergency shut-off, and supply to each fueling system.
- Install emergency telephone and public address system compatible with existing WIPP systems.
- Install area lighting.
- Install perimeter fencing with access gates.

The subcontract duration will be from actual date of award through NWP's final acceptance of the work performed as set forth in the selected <u>subcontractor's accepted schedule</u>.
