The purpose of this sources sought notice is to determine the interest of available Subcontractors to perform **Nondestructive Assay Characterization Support Services for Transuranic Waste** at the Waste Isolation Pilot Plant (WIPP) Facility, located near the vicinity of Carlsbad, New Mexico and other Host sites as specified in accordance with the attached Draft Statement of Work (SOW). SIMCO is conducting a market survey to determine the availability and technical capability of all qualified businesses who could perform Nondestructive Assay (NDA) Characterization Support Services for Transuranic (TRU) Waste.

SIMCO's decision to award the subcontract either through **Full and Open Competition** or as a **Small Business Set Aside** will depend on the business classifications who respond to this sources sought and the number in each classification that are deemed qualified to perform the services. Any award would be in accordance with the SOW, specifications, design drawings, applicable codes and other standards referenced in the solicitation documents.

#### **Synopsis of the Work to be Performed:**

The purpose of this procurement is to award **an Indefinite Delivery/Indefinite Quantity (ID/IQ)** Subcontract to a vendor who shall perform NDA Characterization Support Services for Transuranic Waste. The IDIQ and resulting Task Orders will be awarded either as Firm Fixed Price or Time and Materials, as applicable.

#### **The following is a brief description of the scope of work:**

The Subcontractor shall provide qualified personnel to perform NDA Using Central Characterization Program (CCP) supplied, Subcontractor owned, government furnished, or leased equipment. See the attached draft copy of the SOW for all of the technical requirements, deliverables, etc.

Estimated Solicitation Issuance Date: Middle of March 2024

Estimated Proposal Due Date: Middle of April 2024

It is anticipated that the Subcontract duration will be for a base year with four one-year options.

Estimated total price is between \$70M and \$85M.

This acquisition is under NAICS code 541330, Engineering Services, with a size standard of \$25.5M. Firms responding should indicate what their business size status is in response to this NAICS code. Teaming arrangements and joint ventures will be considered.
